Applicant's company should have valid membership of any Chamber of Commerce & Industry or Association of Trade & Industry affiliated with FPCCI. Valid membership Certificate to be submitted. 3. Membership Form available on FPCCI's website or can be obtained on request. 4. The membership certificate for the Joint Chamber is for two calendar years against a membership fee of Rs. 12000/- only. However, the Membership of Business Councils is for one calendar year against a membership fee Rs. 5000/- only. 5. Membership Fee may be made in the form of pay Order/Demand Draft favouring FPCCI at the earliest. 6. The elections of all Business Councils are in process for the year 2014. Those members who have valid membership of these Business Councils will be eligible to participate in these Elections. 7.
